2. Interested vendors having sufficient experience and expertise for AC maintenance and related jobs are requested to submit their best offer (quotation) as per terms and conditions mentioned below:-

## **Terms and Conditions**

- (a) Rates and scope of work for comprehensive AMC/ Non comprehensive AMC should be mentioned separately.
- (b) Routine service includes routine inspection, checking & servicing of Air Conditioners once in every quarter.
- (c) Routine service should be recorded in service Maintenance Record Card signed by the official concerned of the Commission and produced along with bill.
- (d) Quarterly payment will be made within 15 days of receipt of the bill.
- (e) All breakdown calls have to be attended within 24 hours from the time of report.
- (f) The vendor must have PAN Number & VAT Registration Number, Service Tax Registration Number.
- (g) Bank particulars are required to be submitted alongwith bills for making payment through NEFT/RTGS.
- (h) The offer should be valid for 3 months.
- (i) The AMC rate quoted shall be firm.
- (j) Statutory taxes, if applicable, is to be mentioned and will be paid separately.
- 3. Penalty for delayed/non performance against routine service & break down service shall be imposed @ ½% of the order value for delay per week or part thereof since the date service is due and in case of breakdown from the date of intimation subject to maximum 5% of order value.
- 4. The Commission reserves the right to foreclose the AMC with 02(two) months notice and payment on prorata basis.
