Maximum time as allowed in the concerned regulations is five
			(5) working days from the date of receiving the information along with the approved gist by the licensees / generating companies from the Commission.
			2.0 Licensees has now expressed their difficulties to publish the gist in the newspapers within the time limit as specified in the relevant regulations maintaining the procedure as prevailed.
			<ul><li>3.0 The Commission after careful consideration of the facts as stated by the licensee, decides that the time limit for publication of the gist in the newspapers and the website shall be within six (6) working days from the date of receiving such information from the Commission containing the approved gist irrespective of number of days as specified in the relevant regulations.</li></ul>
